Special Events-Gallery Receptions & Artist Shows: *Lockwood Mathews Mansion Museum* (LMMM), a National Historic Monument in Norwalk, CT, continues its quest for its restoration by developing programs that support this venue. These exhibitions are wonderful opportunities for LMAA artists to show their work and support this critically important project.

Terms and Conditions for Sale of Artwork: Checks and credit card payment for purchase of artwork, including CT sales tax, shall be made out to the Lockwood Mathews Mansion Museum. If the artwork is sold, 30% of the sale price will be retained by the LMAA and 70% of the sale price will be remitted to the artist by check from the LMAA. The LMAA will retain and remit the sales tax. As a not-for-profit organization, the LMAA provides the artist with an opportunity to exhibit but does not assume the role of agent or representative.

A fee, payable to LMMM, to enter the juried exhibition is \$35 and grants consideration of up to three paintings per artist. The artist must also be a member in good standing, of the Fairfield County Arts Association as of the receiving date. Dues are \$25, payable to FCAA.

Eligible Art: Only original work is acceptable for this show. Largest size on all sides is 36". Regarding graphic arts, hand-made prints, giclees, photographs, off-set lithographs, and other prints made using xerographic, digital, or photographic processes do not qualify. All must be framed, or with suitable finished edges and wired ready for hanging.

Please note: Submittal of all artwork, framing, and other materials is at the artist's/submitter's sole risk. Both LMAA and FCAA assume no responsibility for loss or damage. The artist agrees to commit accepted works for the duration of the exhibit. The LMAA reserves the right to remove or not accept any art for any reason at any time. The entry of your artwork in this exhibit constitutes your acceptance of these terms.
